6. Report of the Chair (Discussion, all matters in this item are information only)

Ric Miles provided the following Chair report:

Steering Committee Meeting Date: Tuesday, December 3, 2024

- The Planning Council held its annual meeting with the Mayor on December 3, 2024.
- The Chair provided a detailed report on the Planning Councils legislative work the have completed through the grant year to the Mayor of the City of Paterson.
- The mayor swore in and welcomed all new commissioners to the council that were present.
- The council talked about the upcoming chair elections and the process that will be completed heading into the January meeting.
- The council gave special acknowledgement to Karen Walker for her years of dedication to the HIV field.
- The council remains on track with its legislative responsibilities per the Planning Council's Activity Timeline.

- a. **Review PCAT Planning Council Activity Timeline January 2025** Support staff reviewed the current Planning Council Activity Timeline, and the Planning Council remains in compliance with its legislative requirements.
 - Proposed changes to the PCAT for 2025/26 Grant Year Planning Council Support staff
 reviewed the proposed PCAT for the 2025/26 grant year versus what the recommendations
 from the Health Resources and Services Administration (HRSA) guidance and will review this
 information during the upcoming SPA committee meeting.

b. Receive reports of Standing Committees

Ric Miles provided the following report for the Strategic Planning and Assessment Committee: **Meeting Date:** Tuesday, November 12, 2024

- The committee was informed that the recipient is currently working with subrecipients at
 the provider meetings to coordinate on some of the upcoming service delivery changes. We
 would like to give the recipient's office more time to work through the changes and bring
 back to present to the PC by January.
- Support staff reviewed the nomination process for the new chair of the Planning Council and noted that chairs of the subcommittee will be selected in February with the process beginning in January.
- The committee reviewed its activity timeline and remained on target with all legislative requirements.
- The committee noted that the unobligated balance estimate (UOB) is due in December and that outreach has already begun with the recipient to complete this process.
- Members complete the feedback for the meeting.

- The goal is to have a plan in place by March.
- There have been some issues with patients getting emergency care and they were advised to reach out to Phil at the recipients office.

- The Planning Council reviewed the membership attendance and noted the number of attendance violations for the 12-month consecutive period in accordance with the bylaws.
- Monique Springer was noted to have had 3 absences in the 12-month period. This was discussed with Monique during the meeting and noted.

f. Address membership recruitment campaign(s).

- Bring One Campaign The Committee addressed the current bring one campaign and noted that we are currently at 29% unaligned reflectiveness. The goal of the PC is to reach 33%.
- The Committee talked about its strategies to improve these numbers by changes in meeting times, and scheduling evening meetings.
- The chairs also noted that they would be in touch with Hackensack for engagement in the Local Public Health areas. Ric is also working with the hospital to discuss their future role on the Planning Council.
- Montclair was also interested but needed to see what representatives were available to attend the meetings. The chairs will follow up.
